Treasurer Financial Updates (Phil) -

• Financial Statements --The checking account has a balance of \$68,209.73 (about \$16,000 is a portion of loan); the Mission account has a balance of \$0 and has been closed; the Cornerstone account balance is \$75,876.05; the Memorial Savings account balance is \$15,188.90; the Edward Jones account has a balance of \$61,208.08 (money from anonymous building fund donation and sale of Johnson & Johnson stock) and the RaiseRight checking account balance is \$3,560.94. The Cornerstone account earns a higher interest rate. The Edward Jones account is not intended to hold funds for extended periods due to lower interest amounts. Gross Profit total of \$117,296.77 (2025 Budget is \$60,711.96), Total Expenditures come to \$71,984.05 (2025 Budget is \$54,750.14). The Brat Fry profited 888.36. Note for the future Pig had good sales that kept food cost down. Any memorial money from the Bev Mueller funeral is to be dedicated to the Building Fund per the family's request. The total to date is \$2925. Phil and Kris worked together this past Monday.
