READY FOR IN-PERSON SUNDAY MORNING WORSHIP

There were times over the last thirteen months that it seemed like this day would never arrive. The weeks and months were made more difficult for our congregation by a transition process that began before the pandemic was on anyone's future projections. When churches began to meet virtually in March of 2020; how could any of us have known all that would take place? Thanks to the historically fast production of three highly effective vaccines, we finally believe that we can worship safely again. **The church will reopen this coming Sunday morning, May 2nd!** We will celebrate Communion in this season of Easter. Perhaps it is theologically fitting that in a season which lifts up resurrection and the movement from death to new life in Christ, we too are able to join together in person once again for life affirming, praise to God!

The Reopening Team made up of Savannah Anderson, Brett Dimmer, Doug McManus, Kerry O'Brien, Tom Roehrig, Mike Spalding, Phil Stepanski and myself put together a plan to reopen the church safely even as the Coronavirus continues to be a threat. Using the best information available from the Ozaukee County Health Department and recommended guidelines from the nationally respected Wisconsin Council of Churches, we recommended to the Church Council in February that we would be able to reopen for in-person worship once the Ozaukee County vaccination rate had hit 50% and new infections stayed at or below 10 new cases per day per 100k residents (seven day average) and the percentage of positive Covid-19 test results stayed at or below 10% (fourteen day average). We believed that increasing protection from the virus as well as decreasing activity of the virus in the community would indicate that it would be relatively safe to resume worship with precautions in place.



These decisions have generated some “heat” in the congregation. We have heard from those who felt it was ridiculous that we had not opened long ago, as well as those who were clear that they believed we were moving too quickly and would bear responsibility for new infections. The Reopening Team was very aware of the conflict and steered a middle path between competing views, all while staying committed to their plan despite a slowing and plateauing of vaccinations and the threat of a fourth wave of infections.

Chocolate Butter Logs

1 cup butter, softened
1/2 cup powdered sugar
1 teaspoon vanilla extract
1 teaspoon almond extract
2 cups all-purpose flour
Multicolored nonpareils or sprinkles, optional
2/3 cup semi-sweet chocolate chips

Preheat oven to 350 degrees F. In mixing bowl, beat butter and sugar; add extracts, mixing well. Gradually add flour; mix well. Shape teaspoonfuls of dough into 2-1/2 x 1/2-inch logs; place on ungreased cookie sheets. Flatten logs diagonally with fork dipped in flour; sprinkle tops with nonpareils or sprinkles, if desired. Bake at 350 degrees for 10 to 12 minutes or until lightly browned on bottom edges. Cool on wire cooling racks. In saucepan or microwave, melt chips; spread thin layer over bottom of each cookie. Place top side down on waxed or parchment paper; let stand until chocolate hardens. Makes about 4 dozen.



Church Team Spotlight - Our Involvement with Lighthouse

(article written by Ray Shupe, Church Member and President of Lighthouse)

Question: What represents 5 churches with 4 ministers, and 3 faiths, in 2 communities, and 1 school district?

Answer: Port Washington Saukville Ecumenical Youth Ministry d/b/a (doing business as) Lighthouse Youth Ministry!

A little over 3 years ago in late Winter 2018, Jeff Suddendorf met with 3 other area pastors for coffee and started bouncing around the idea of a multi-faith, multi church youth group... an ecumenical youth ministry so faiths could work together. None of the churches had enough kids, money, and/or volunteers. So why not pool resources? Well, that is exactly what we did and today we operate as Lighthouse Youth Ministry. Providing a safe environment for youth from 5th grade to 12th grade.

I got involved with Lighthouse early in the start-up while serving as Moderator on the First Congregational Church Council. After Lighthouse incorporated and we received our 501 (c) (3) tax exempt status in mid-2018, I was elected to the position of President of the Lighthouse Board. I have proudly served in that position and, along with Savannah Anderson, we have represented First Congregational on the Lighthouse Board.

Lighthouse has experienced many changes from the time we were meeting to figure out how to do this and what needed to be done. In addition to developing By-laws, Articles of Incorporation, tax exempt status, and policies and procedures to protect the youth, we:

1. obtained a d/b/a name and developed a logo,
2. have a permanent "headquarters" at 505 W. Grand Ave (the Family Activity Center at Grand Avenue Methodist Church) procuring a 5-year lease for \$1.00/year rent,
3. have hired a Youth Director,
4. developed a webpage (lighthouseyouth.org) and a Facebook page,

5. had several successful fundraisers,
6. remodeled the "headquarters" to be more modern and appealing to the youth,
7. expanded to include kids from around Ozaukee County,
8. sponsored some kids to youth summer camps,
9. created separate middle school and high school groups,
10. had many fun outside activities (sledding/tubing, mini golf, movies at the theater, civic activities, and campfires),
11. have survived the Covid-19 pandemic through good connections with the kids.

When the schools stopped in person education, we stopped face to face meetings with the kids. We turned to Zoom and held weekly meetings that including cooking contests and training, trivia games, and whatever our Youth Director, Erica Brooks, could come up with. As a result, we are emerging from the last year with momentum and are now holding weekly CDC compliant youth meetings.

We thank First Congregational Church for the congregation's continued support of our important mission...supporting the youth of our community. APRIL CHURCH COUNCIL MINUTES

The April 15, 2021, the Church Council meeting was called to order at 7:03 p.m. by Jeanne Mantsch, Moderator.

Present were: Jeanne Mantsch, Phil Stepanski, Reverend Dr. Scott McLeod, Savannah Anderson, Kathy Bretl, Jason Jacque, Eric Olson, Ric Probst, and Mike Spalding

Opening Meditation - Marti was scheduled to give the opening meditation, but was not in attendance. Pastor Scott led us in an opening prayer.

Approval of the Minutes - This was moved to New Business.

Financial Administrator's Report- Lorraine Halls, Financial Administrator, provided a Statement of Activity for January - March 2021 and a Budget vs. Actuals: January - March 2021.

Several questions/suggestions arose - Mike Spalding: What is the \$733 under Pulpit Support, it would be more clarifying to put the category title at the top of the section, he'd like to see the approved budget amounts next to the monthly totals so they can be compared line by line, and is it possible to create a line for each line in the budget; Jeanne would like to be able to use the budget as a guide; and Phil believes the format could be clearer. All of this was discussed keeping in mind that Lorraine is learning as she goes there is confidence that, in a couple of months, things will come together. Kathy will connect with Lorraine to share questions/suggestions.

Pastor Scott told us that Lorraine shared that more pledges were received in March. Kathy will ask Lorraine to share the specifics with Jason so the Stewardship Team can follow up.

Old Business

Reopening Team Report- Phil said that the Team met on Tuesday and they covered the same territory - looked at numbers, etc. As of today, the Vaccination Rate is 46.1% (the Team decided to consider 1 vaccine, as opposed to full vaccination rate), the 7 day average of positive tests is 10.7%, and new cases per 100,000 is 12.0, which is down 1/10 from 4/13/21. They decided that they will weigh the numbers as #1 - New Cases/100,00; #2 - Vaccination Rate; and #3 - 7 Day Average of Positive Tests.

They continue to monitor the numbers for any sign of a spike because they do not want to compromise what they have decided the parameters are, but they do plan to be a little flexible. While worshiping in person has been cancelled for this Sunday, they do believe it will be possible in the very near future. This Sunday, the Team plans to record a "What to Expect" when worshiping in person video. *(continued on next page)*

In terms of the flexibility mentioned earlier, a request from Port Preschool 3K for a gathering in Fellowship Hall for May 25th, for approximately 44 people has been approved, with the understanding that it will be cancelled if there is a spike in the numbers. (It is expected that we will be worshipping in person by this time. Confirmation Sunday is scheduled for May 23rd, and that is expected to be celebrated in person, as well.)

In addition, the Team has learned that a 30 minute time frame for gathering (especially, small group gatherings) is not realistic. So they believe the gathering time also needs flexibility.

The Team realizes and understands that there is a lot of frustration related to worshipping in person, but they are trying to be true to what they believe are the safest standards for reopening.

Financial Separation of Duties- Jeanne reported that she, Pastor Scott, Lorraine, and Kathy have not met again, but plan to in the coming week to finalize the duties.

New Business

Justice Team Representation on Council? Others?- Jeanne said the Justice Team met on Monday and decided they would not like to have a representative on the Council. They would prefer to work through the Community Outreach Team/Eric so that someone in the governing body of the church knows what the Team is doing. Eric thinks it is appropriate for Community Outreach to connect with the Justice Team, and he will be happy to work with them.

Pastor Scott added that there are other ideas for new teams that will fit well with existing teams. Examples: A Pastoral Care Team, which will take care of following up with loss or joyful events with congregation members, will fall nicely under Fellowship; a Pastoral Relations Team will be added to Staff Support and Review; and Lighthouse Ministry will fall under Christian Education. This will create a "chain of command". It won't give Council members more to do, but rather will get more people involved. Another example is the Liturgy Team that has huge responsibilities, but Mike Spalding shouldn't have to be the only one doing all the work. Putting teams together will help get the work done and create a reporting structure.

Approval of March, 2021 Minutes- Jeanne revisited the minutes and how to best move forward with approval, because the present system of emailing as an attachment, asking if there are any changes, and then asking for approval, is not working. Phil explained that emails on his phone are difficult to find once there's a string of more than a couple, so he asked Brett Dimmer about whether there's a service that could help and Brett said Slack.com.

Pastor Scott suggested Google Docs. If Kathy sends the minutes to him, he'll put them into Google Docs and send to Council members. At first he said he'd give members editing abilities, but then it was decided that corrections (without getting too picky) could be made in a comment section. A list of Council member's names will appear at the bottom of the document and members will put an X next to their name after reviewing them. As long as the minutes are reviewed by a majority of members, they will be considered to be approved.

Pastor's Report - Pastor Scott felt very good with the way the Lenten season, Lenten Connections and Lenten projects went. There was good participation. He said a thank you to Brett Dimmer for all the work done for the services. The Palm Sunday drive-thru with palms and cinnamon rolls was very well received. The e-newsletter has been well received with positive feedback.

A fire alarm recently went off. Scott will work with Jim Clements to update the call list.

Pastor Scott talked with Jeff Suddendorf about a week ago to ask about the Memorial Garden. A member is preplanning a memorial and they plan to be cremated and want to be scattered in the Memorial Garden. Jeff said there is not a Memorial Garden, but did talk with a funeral director a while ago and learned that ashes can be scattered because it would be on private property.

Pastor Scott's church in Elkhorn did have a Memorial Garden and he is in favor of having one as it is a valuable and meaningful way to memorialize someone. He will talk with Jim and get a team together to begin working on one.

Pastor Scott is continuing to be very pleased with everything he's encountered at church. Everything is going well and he's definitely looking forward to in-person worship.

In addition, he feels, and we should all feel, very fortunate to have a great staff, wonderful musicians, and Brett Dimmer handling the YouTube channel. He feels very lucky to have inherited this group.

Pastor Scott and the office staff assigned the Spring Congregational Meeting to the last Sunday of June, June 27. The goal is to have a Nominating Team formed before then, which will be able to present a full slate of Officers and Team members for the new term. Also, Pastor Scott wants to resurrect the writing of annual reports. Each Council member will need to summarize in a paragraph or two what's been going on this year—remember and recall. It will be a powerful statement of the kind of work and hours that have been put in. These paragraphs should be completed and submitted by June 10, 2021.

Jeanne had to call for a vote on adjourning the meeting as it was not on the agenda. All were in favor. Meeting adjourned at 8:14 p.m.
